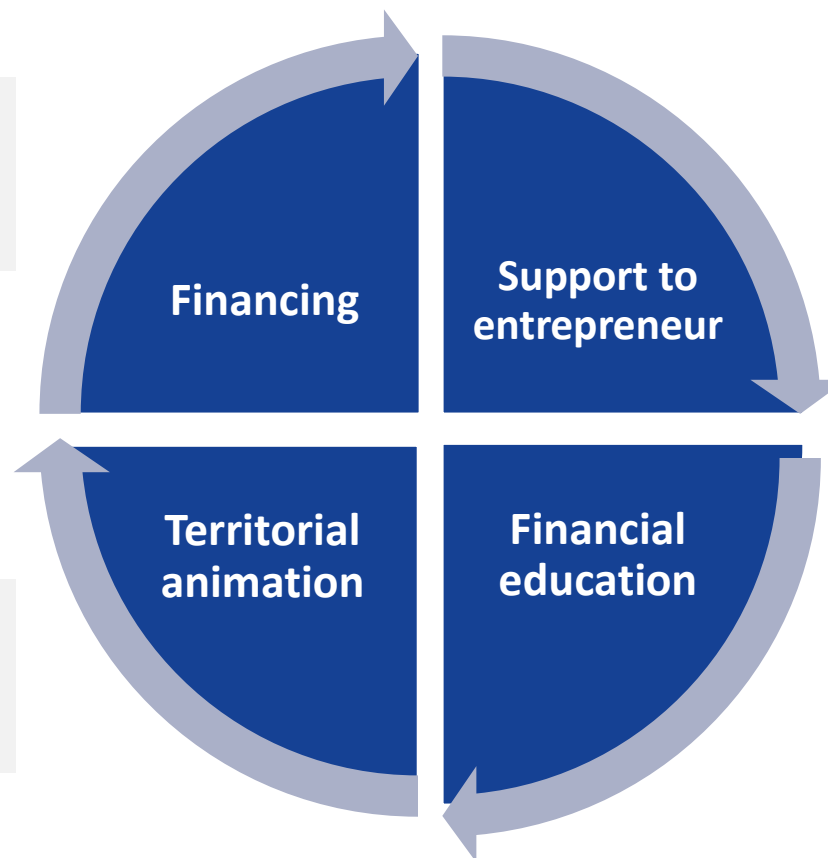

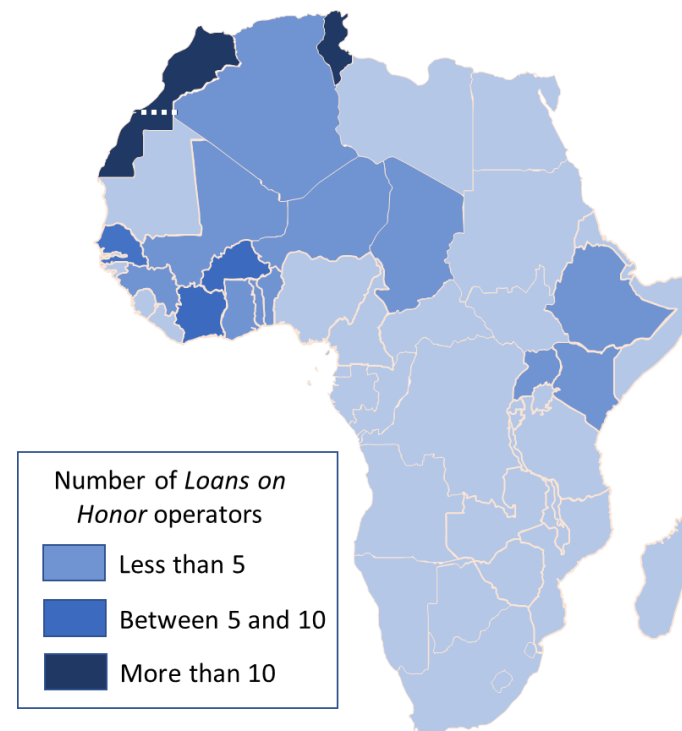

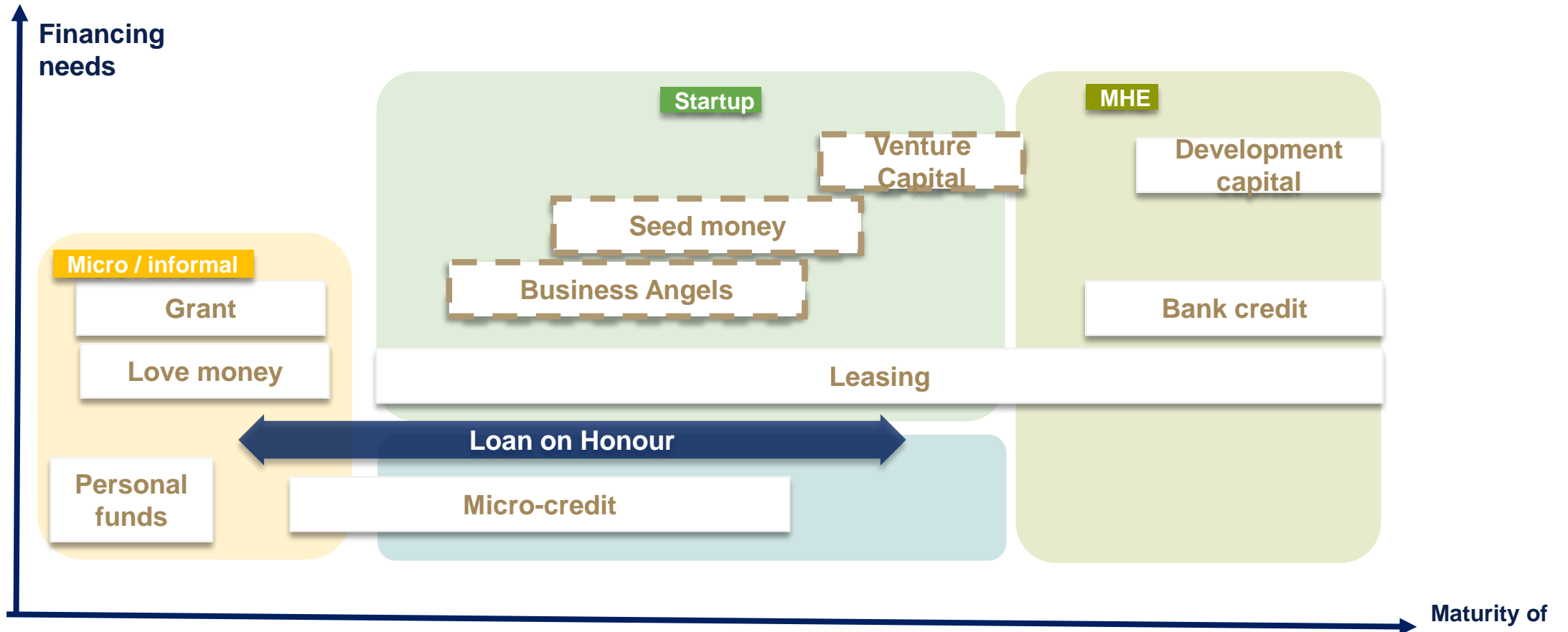
Loans on Honor in Africa

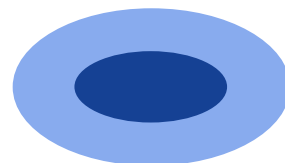
Short term

- Incentives for the formalisation of companies and their business banking



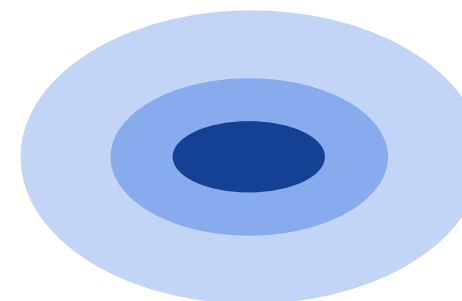
Medium term
